The IRS Impersonators usually will call from the number 727-591-6554; however, the IRS Impersonators appear to now be changing their phone numbers on a weekly basis.

In the event you receive such a call; do not talk to the Caller OR return the call to the number provided in the message the Caller left for you; the Caller is a Scam Artist and he (she) is trying to rip you off; any and all information that you provide to the Caller will likely be used for ! such purposes.

If extreme weather requires a cancellation of the January 15th hearing it shall be held on Monday, January 19, 2015 at the same location and time.
